Salt Lake County

Emissions Requirements

Vehicles registered in Salt Lake County with model years **less than six years old** are required to have an emission test once every two years. Vehicles in this category that have even-numbered model years must have an emission test in even-numbered years, and vehicles that have odd-numbered model years must have an emission test in odd-numbered years.

Exemptions

- New vehicles with an MSO

- Any vehicle with a model year 1967 & older
- Any diesel vehicle with a model year 1997 & older and with a GVWR less than 14,000 lbs.
- All implements of husbandry
- Off highway vehicles
- Electric vehicles
- Motorcycles or motor driven cycles
- Farm vehicles
- Maintenance or construction vehicles not designed or licensed to operate on a highway
- Vintage vehicles model year 1982 & older or custom vehicles

Davis County

Emissions Requirements

Vehicles registered in Davis County with model years **less than six years old** are required to have an emission test once every two years. Vehicles in this category that have even-numbered model years must have an emission test in even-numbered years, and vehicles that have odd-numbered model years must have an emission test in odd-numbered years.

Exemptions

- New vehicles with an MSO
- Any non-diesel powered vehicle with a model year 1967 & older
- Implement of husbandry (Farm) vehicles
- Any vehicle used for maintenance or construction and not designed or licensed to operate on the highway
- Any motorcycle or motor driven cycle
- Off highway vehicles
- Electric vehicles

- Vintage vehicles model year 1982 & older or custom vehicles

Note: A vintage vehicle that has a model year of 1983 or newer is required to provide proof of an emissions inspection or provide proof of vehicle insurance that is a type specific to a collector vehicle. See form [TC-745, Vintage Vehicle Insurance Affidavit](#) for more information.

If the vehicle is located in an area where emissions inspections are NOT required, you must provide one of the following documents as evidence that the vehicle is located out of state:

- 1) A VIN Verification Form completed by local law enforcement.**
- 2) Active Military Orders showing location.**
- 3) Valid School Parking Permit.**

Utah County

Emissions Requirements

Vehicles registered in Utah County with model years **less than six years old** are required to have an emission test once every two years. Vehicles in this category that have even-numbered model years must have an emission test in even-numbered years, and vehicles that have odd-numbered model years must have an emission test in odd-numbered years. **Diesel powered vehicles with model years 1998 - 2018 require an emissions inspection in Utah County.**

Exemptions

- New vehicles with an MSO
- Any vehicle with a model year 1967 & older
- Implement of husbandry (Farm) vehicles
- Any vehicle used for maintenance or construction and not designed or licensed to operate on the highway
- Any motorcycle or motor driven cycle
- Electric vehicles
- Diesel powered vehicles with a model year 1997 & older
- Off highway vehicles
- Any diesel vehicle with a GVWR greater than 14,000 lbs.
- Diesel vehicles 2019 and newer
- Vintage vehicles model year 1982 & older or custom vehicles

Note: A vintage vehicle that has a model year of 1983 or newer is required to provide proof of an emissions inspection or provide proof of vehicle insurance that is a type specific to a collector vehicle. See form [TC-745, Vintage Vehicle Insurance Affidavit](#) for more information.

Vehicles located in areas WITHOUT Emission Requirements

Weber County

Emissions Requirements

Vehicles registered in Weber County with model years **less than six years old** are required to have an emission test once every two years. Vehicles in this category that have even-numbered model years must have an emission test in even-numbered years, and vehicles that have odd-numbered model years must have an emission test in odd-numbered years.

Exemptions

- New vehicles with an MSO
- Any vehicle with a model year 1967 & Older

- Any vehicle used for maintenance or construction and not designed or licensed to operate on the highway
- Any motorcycle or motor driven cycle
- Electric vehicles
- Any diesel vehicle 1997 & older or with a GVW greater than 14,000 lbs.
- Off highway vehicles
- Vintage vehicles model year 1982 & older or custom vehicles

Note: A vintage vehicle that has a model year of 1983 or newer is required to provide proof of an emissions inspection or provide proof of vehicle insurance that is a type specific to a collector vehicle. See form [TC-745, Vintage Vehicle Insurance Affidavit](#) for more information.

If the vehicle is located **more than 60 miles from an area where emissions inspections are NOT required**, you must provide one of the following documents as evidence that the vehicle is located out of state:

1. A completed VIN Verification Form. [Download Here.](#)
2. Active Military Orders showing location.
3. Valid School Parking Permit.

Cache County

Emissions Requirements

Vehicles registered in Cache County with model years **less than six years old** are not required to have an emission test. Vehicles six years old and greater that have even- numbered model years must have an emission test in even-numbered years, and vehicles that have odd-numbered model years must have an emission test in odd-numbered years.

Vehicle Model Year	Emission Inspection
2023 to 2018	Not required
2017 to 1996	Biennial
1995 and older	Not required

Exemptions

- New vehicles with an MSO
- Any vehicle with a model year 1968 & Older
- Implement of husbandry (Farm) vehicles
- Any vehicle used for maintenance or construction and not designed or licensed to operate on the highway
- Any motorcycle or motor driven cycle
- Electric vehicles
- Off highway vehicles
- Any vehicle less than six years old

- Any diesel vehicle 1997 & older or with a GVWR greater than 14,000 lbs.
- Any gasoline (and non-diesel based alternative fuel) vehicle with a model year of 2007 and older with a GVWR greater than 8,500 lbs
- Vintage vehicles model year 1982 & older or custom vehicles

Note: A vintage vehicle that has a model year of 1983 or newer is required to provide proof of an emissions inspection or provide proof of vehicle insurance that is a type specific to a collector vehicle. See form [TC-745, Vintage Vehicle Insurance Affidavit](#) for more information.

If there is no emissions inspection program available where your vehicle is located, you must provide documentation of the vehicle's location by submitting a completed VIN Verification Form from the local law enforcement, motor vehicle department, or if applicable; university or campus police, or a military base official. Please use the attached VIN verification form if the local official does not provide a VIN Verification Form. This form must be signed by local law enforcement, military or campus police.
