<u>Types of Vehicle Ownership</u>

- **Tenants by the Entirety/Spouses** (TEN ENT) Married couples (including Civil Unions), where ownership of property is treated as though the couple was a single legal person. Owners have a *right of survivorship*, if one owner dies, interest in the property will pass to the surviving owner avoiding probate.
- **Joint Tenants** (JTEN) Co-owners have a *right of survivorship*, if one owner dies, interest in the property will pass to the surviving owner avoiding probate.
- Tenants in Common (TEN COM) No right of survivorship, if one owner dies, interest in the property will be part of their estate.
- Business Partners (PTNERS) No right of survivorship, if one owner dies, interest in the property will be part of their estate.
- Transfer on Death (TOD) One owner only, <u>DMV form VT-007</u> required.
